POLICY

It is important that each employee present a professional appearance to our patients and the public. Neatness, cleanliness and appropriate attire are required of all Pikeville Medical Center (PMC) employees.

The success and acceptance of our company depends to a great extent upon the image the employees present to the public and our patients on a daily basis.

No policy can specifically address each and every conceivable circumstance or condition. The standard required of employees is that of a professional appearance and this policy provides general guidance to employees concerning maintaining that professional appearance. PMC reserves the right to address any appearance it deems unprofessional.

To Whom Does this Apply?

- All PMC employees
- Trainees and Students
- Volunteers
- Contractors

NAME BADGES

All personnel must wear above their waist their official PMC-issued name badge at all times while working at PMC.

The blue informational badge must be worn behind the name badge at all times. Employees issued a departmental color-coded badge backer must wear such badge backer with their badge at all times.

The lettering on badges must NOT be worn or faded. Badges with faded lettering should be replaced immediately.

Lanyards and badge reels for the badge are permitted but must not contain a logo (other than PMC's or the relevant PMC Center of Excellence logo) or contain words or images deemed offensive or inappropriate by PMC. When badges are worn on lanyards, the badge must still be above the waist.

No stickers are to be put on the badge. Pins or other items must not be stuck through the badge.

PERSONAL HYGEINE

Good personal hygiene must be observed by all. Hair must be clean, well-groomed and neat. Long hair must be worn in a controlled manner, away from the face if working with patients.

Beards, mustaches and goatees must be kept trimmed and well groomed; otherwise, employees are expected to be clean shaven.

Artificial fingernails and nail polish are restricted in some work areas as outlined in the Infection and Prevention Control policies and procedures.

JEWELRY, PIERCINGS, & BODY MODIFICATION

Jewelry is to be conservative and in good taste. It must not hinder any work being performed.

Facial piercings and visible body piercings are prohibited except that a single nose stud not to exceed 2.5mm is permitted on the side of the nostril in all work areas unless (i) deemed unsafe by department policy or (ii) it is necessary for the individual to wear an N95 mask and the nose stud interferes with the proper fit of the mask. Jewelry is not permitted on any other part of the nose. When in an area deemed unsafe for nose studs per department policy, employees are required to remove the stud and not insert a spacer.

Visible intentional body modifications for non-medical reasons such as tongue bifurcation, unnatural shaping of the teeth, ears, scarification, and body modifications for the purpose of suspension (body hooks) are likewise prohibited.

Earrings and ear gauges are acceptable unless deemed unsafe by department policy. Ear gauges must be 12.7 mm or smaller. Anything over 12.7 mm must be covered while working.

TATTOOS & BRANDING

PMC allows reasonable self-expression through tattoos and branding but prohibits those that PMC determines are or could be offensive or harassing toward patients, co-workers or other persons who conduct business with PMC or and have contact with PMC employees. Prohibited tattoos and brands include, but are not limited to, those that:

- are affiliated with, depicting, or symbolizing extremist philosophies, organizations, or activities;
- are offensive to modesty, decency, propriety, or professionalism;
- advocate a philosophy that degrades or demeans a person based on gender, race, ethnicity, sexual preference, or national origin; and
- are located on the head, face, or neck (anything above the T-shirt line to include on/inside the eyelids, mouth, and ears) except that “permanent makeup” tattoos for eyebrows and eyeliner are permitted so long as applied modestly.

All prohibited tattoos and brands must be covered while at work. Prohibited tattoos and brands which, in PMC's determination, cannot be feasibly covered, may require the employee to be separated from employment.

Any employee who is considering a new tattoo or brand may submit the design and location to the HR Department in advance for a determination of whether the employee would be required to cover the tattoo or brand while at work.

UNIFORMS

PMC requires its personnel to wear the uniform designated for their department. Departments are generally either assigned to wear **scrubs** or **business casual**. A listing of departments and their assigned uniform type are in the tables attached to this policy.

All attire must be clean and fit correctly. Baggy, torn, ripped, tattered, revealing or tight attire is not considered acceptable in a professional work environment, regardless of fashion trends. Capri

and ankle style pants are acceptable when worn at acceptable mid-calf length and/or ankle length.

Exclusive Vendors

Scrubs & Jerseys

Scrubs & More is PMC's exclusive scrub vendor. All scrubs must be purchased from Scrubs & More. Scrubs & More and the Corner Market are the exclusive vendors for official PMC jerseys. All jerseys must be purchased from Scrubs & More or the Corner Market.

Business Casual

Land's End and Scrubs & More are the exclusive vendors for business casual tops.

Exceptions

1) Management of Scrub-Wearing Departments

Management personnel of scrub-wearing departments may wear business casual in accordance with the business casual guidelines of this policy depending on their intended tasks for the day.

2) AVA Center

With approval by the CEO, AVA Center employees may wear (i) special theme clothing such as Halloween costumes, school spirit week outfits, water apparel, or others as part of the therapy provided to learners to assist them with anxiety, sensory, or other issues in learning to cope with certain life situations; (ii) specifically approved short pants on certain days designated by management as hot weather days during the months of April through October; and (iii) solid black or blue jeans. Jeans must not have holes, not be faded or worn, and not have a baggy waist or baggy legs.

3) AVA Academy

Management employees must wear a solid black or white short or long-sleeved polo shirt with the official AVA Academy patch on the upper left chest. Other employees must wear the approved AVA Academy jerseys. Staff may wear a solid black or white long sleeve shirt under the jersey. All staff must wear (i) black scrub pants; (ii) solid black or blue jeans that do not have holes, are not faded or worn, and do not have a baggy waist or baggy legs; or (iii) specifically approved short pants on certain days designated by management as hot weather days during the months of April through October.

4) Mettu Children's Hospital, PMC Peds Clinic or PMC Specialty Peds Clinic

Employees of the Mettu Children's Hospital, PMC Pediatric Clinic, or PMC Specialty Pediatric Clinic may wear PMC-approved pediatric scrub tops with matching color scrub pants sold by Scrubs and More.

5) Christmas

During the full month of December, employees may wear holiday sweaters or sweatshirts so long as they are in good taste, adhering to modesty, decency, propriety, and professionalism.

6) Executive and Administrative Leadership

Senior Executives and administrative employees (with the approval of their Senior Executive) may wear formal business attire in lieu of business casual.

7) Physician Recruitment, Physician Referral Services, and Public Relations

Formal business attire should be worn:

- by Physician Recruitment employees when meeting physician candidates;
- by Physician Referral Services employees when making calls on outside parties;
- by Public Relations employees when hosting groups, special guests, or dignitaries at PMC.

8) Starbucks

PMC employees working in Starbucks must wear the official Starbucks uniform.

9) Ambulance Service

PMC employees working in PMC's ambulance service may wear the official PMC designated EMS shirts and Jackets.

10) Chaplains

Chaplains may wear the official PMC designated chaplain shirts.

11) Licensed Practitioners

For purposes of this policy, Licensed Practitioners (LPs) are physicians, nurse practitioners, and physician assistants. LPs may wear:

- Scrubs that are:
 - Black;
 - Their department's designated scrub color until needing replaced and black thereafter;
 - PMC-provided scrubs in the relevant color if working in one of those departments;
- Scrubs in one of the above approved colors covered by their official PMC lab coat;
- Business casual attire covered by their official PMC lab coat;
- Formal business attire; or
- Formal business attire covered by their official PMC lab coat.

The official PMC lab coat must either have the provider's department's Center of Excellence logo or the PMC logo in the upper right chest area and the provider's name stitched on the left upper chest area.

12) Painters

PMC employees working as painters must wear white painter pants and a white PMC approved polo.

13) Plumbers and Plumber Helpers

PMC employees working as a plumber or plumber helper must wear black PMC approved polos with navy pants.

14) Plant Operations/Maintenance/Grounds

Effective December 1, 2025, PMC employees in this department must wear black PMC approved polos or a PMC approved jersey with black or gray pants.

15) Volunteers

Volunteers are expected to wear business casual attire (which may or may not contain the PMC logo) covered by the official PMC volunteer vest.

16) Contractors

Contractors are expected to dress in accordance with any applicable provisions of the contract between PMC and their company. PMC will endeavor to achieve attire for contractors that is consistent with garments for PMC employees.

17) Religious Accommodation

PMC will consider and approve exceptions based on religious beliefs as required by law in accordance with PMC's policies on religious accommodation.

18) National Wear Red Day

On National Wear Red Day, employees may wear a solid red shirt as long as it is in good taste, adhering to modesty, decency, propriety, and professional.

Caps & Hats

Caps and hats may only be worn if approved by PMC as part of the official department uniform. Employees of those departments for whom caps and hats are approved may wear clean, approved PMC caps and hats inside and outside PMC buildings.

Cold Weather Outdoor Attire

Employees of the Valet, AVA Center, Drive Through Diagnostic Lab, Facilities, and Maintenance departments, when assigned to work outdoors in cold weather, may wear PMC toboggans, jackets, and/or coats purchased from PMC's exclusive vendor(s) as well as solid-colored gloves and winter/safety footwear that are professional and neat in appearance.

SHOES

For safety purposes no sandals (platform or flip flops), no shoes with open holes (clogs style with holes), or open toe shoes are permitted to be worn in areas of patient care. Professional clogs and tennis shoes are permitted.

PROHIBITED GARMENTS

The following garments are specifically prohibited unless approved by the CEO:

- T-shirts;
- Shorts;
- Sweatpants of any kind;
- Denim jeans of any color
- Leggings or tights worn as pants; and
- Revealing garments.

POLICY ENFORCEMENT

It is the responsibility of each Director and Manager to confirm that his or her employees project a professional image to the patients and public and conform to the requirements of this policy.

PMC reserves the right to require any employee in violation of this policy to go home and change clothing, or take other remedial measures, and return to work with the loss of pay for time absent. PMC also reserves the right to remove any non-employed personnel (e.g. contractors, students, volunteers, etc.) in violation of this policy from PMC's premises.

Repeated violation of this policy warrants progressive disciplinary action up to and including termination and is documented in the employee's personnel file.

ADDITIONAL EXCEPTIONS

Additional exceptions to this policy must be reviewed and approved by the CEO.
